Privacy Statement

ADOPT A CHRISTCHURCH FAMILY TRUST is committed to the protection of personal privacy and has adopted the policy set out below to protect information about individuals. This policy describes the information ADOPT A CHRISTCHURCH FAMILY TRUST collects at this website, how ADOPT A CHRISTCHURCH FAMILY TRUST uses that information, how that information may be disclosed, the security of that information, how you can access and correct any such information and other relevant details concerning your privacy.

Collection of Personal Information

You may provide personal information to ADOPT A CHRISTCHURCH FAMILY TRUST to receive information about the purposes of the Trust, to make a donation or to receive funds from the Trust. This personal information may include details such as your name, contact information, family situation/needs, bank account information and referee.

The purpose for collecting this information is to provide targeted financial relief to Christchurch families who are affected by the 4 September 2010 and 22 February 2011 earthquakes and their aftershocks and to provide anonymised information back to donors about how their donation has helped a Christchurch family.

ADOPT A CHRISTCHURCH FAMILY TRUST may also collect and store information about your visit to its website, including:

- The name of the domain in which you accessed the internet
- The date and time you accessed the website
- The internet address of the website from which you linked directly to the website
- The pages you accessed while visiting the website

This information does not in itself identify individuals and is used to measure the number of visitors to the website and how it was navigated. This information assists us to make the website more useful to you.

Other than for the purposes described above, ADOPT A CHRISTCHURCH FAMILY TRUST will not use your personal information without your prior consent. The only exception to this rule is where disclosure is necessary to prevent injury to life or health, to investigate any suspected unlawful activity or where it may be required by law such as in a response to a warrant, subpoena or other legal process.

Security of your Information

ADOPT A CHRISTCHURCH FAMILY TRUST will take reasonable steps to ensure security of all information it collects from risks such as loss or unauthorised access, destruction, use, modification or disclosure of data. For example, your personal information is maintained in a secure environment which can be accessed only by authorised personnel.

However, no data transmission over the internet or information stored on servers accessible through the internet can be guaranteed to be fully secure. These activities are taken at your own risk.

Disclosure of Personal Information

Personal information collected by ADOPT A CHRISTCHURCH FAMILY TRUST is not disclosed or passed on to third parties unless it is in accordance with this privacy statement. Information may be provided to third parties where any functions or services are being outsourced and there is a confidentiality agreement in place.

ADOPT A CHRISTCHURCH FAMILY TRUST will not disclose your personal information in circumstances other than those described above without your prior consent. The only exception to this rule is where disclosure is necessary to prevent injury to life or health, to investigate any suspected unlawful activity or where it may be required by law such as in a response to a warrant, subpoena or other legal process.
